In the name of God Amen I Nicholas Barnt of Somerset Township Sumerset County and Commonwealth of Pennsylvania Farmer Being in perfect health of Body and of Sound mind memory and understanding Blefsed be God for the same but Considering the uncertainty of this Transitory Life do make and publksih this my last will and Testamen in manner and form following To wit Principaly and first of all I commend my Immortal soul into the hands of god who gave it and my Body to the earth to be Buried inn a Decent and Christian like manner at the Discretion of my Executors herin after named and as to such Worldly Estate wherewith it hath Pleased god to Blefs me in this life I give and dispose of the same in the following manner and To wit I give and devise unto my dear Wife Catherine all that plantation and Tract of Land Situate in Somerset Township aforesaid Bounded by Simon Shaver Jacob Crifsey and others containing one hundred and fifty one acres more or lefs with the appurtenances for and during her life and after her Death it shall be sold by my Executors for the Best Price which Can be had for the same and the money arising from such Sale Shall be equally Divided among my Children one Share to Jacob Barnt my only Son one Share to my Daughter Catherine intermarried with David Dickey and one Share to the Children of my Daughter Elizabeth intermarried with Frederick Walter this Share to be put to Interest by my Executors or the Survivor of them and the Interest arisinig there from to be paid into the hands of my Daughter Elizabeth aforesaid During her life and after her Death the aforesaid share to be equally divided among her children Share and Share a Like and I further give my wife out of my Personal property whatever She may Chose to Keep and the remainder of the Personal Property to be Sold by my Executors and after paying my just debts the Balance to be Subject to the same Division among my Children as before mentioned with the money arising from the Sale of the Land Elizabeth Share to be at Interest During her Life & after her Death to be equally Divided among her Childrenand the tract of land Situate in Brothersvalley Township in said County Containing one hundred acres Joining Jacob Walker Joseph Crfsner and others Being the same where Frederick Walter now lives I give and Devise unto my Daughter Elizabeth During her life and after her Death I give and devise the aforesaid one hundred acres after the death of my said Daughter Elizavbeth to her Children and their heirs and afsigns for ever to be equally divided among them Share and Share alike and Lastly I nominate Constitute and appoint my son Jacob Barnt and Christian Spangler Executors of this my last Will and Testament hereby revoking all other will legacies and Bequests by me heretofore made and Declaring this and no other to be my last Will and Testament.
