That said deceased at the time of his death was a resident of the
County of Cache in said Territory of Utah
and left estate in said county consisting of real and
personal property:

That the probable value and character of the said property are as follows, to wit:

138 square rods in Block 29 Plat-A Logan City Survey
worth about \$600
2800 sq feet on Block two plat-A Logan City Survey
worth about \$925
Mortgage for \$200 due July 13th 1885 given


In the name of God, Amen.

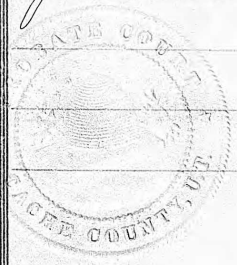
