 Adm^r for ever all that my New wood Cott In Chebacco
 woods In said Ipswich being one of y^e late divisional Cott^s
 Containing about four acres of Land be it more or less
 with all wood and timber thereon as it was laid out &
 bounded by y^e Committee with all priviledges thereto belonging
 being eleven rods wide at y^e west End a beech tree marked
 at y^e East End eleven rods wide a maple tree marked so
 it runs from Range to Range bounded Southerly by y^e
 Cott three hundred thirty five and Northerly by y^e Cott
 three hundred thirty seven To Have and To Hold
 said Cott wth all priviledges thereto belonging or in
 any ways appertaining to him of said John Andrews his
 heirs and Assignes for ever to his & their only proper use
 Benefit and Behafe for ever And y^e said Thomas Day
 for me my heirs Exec^r adm^r do Covenant promise Grant
 to & with y^e said John Andrews his heirs & Assignes that
 before y^e Ensealing hereof I am y^e true Sole & Lawfull
 owner of y^e above bargained promises & am Lawfully Seize
 & possessed of y^e same in my own proper right as a good
 perfect and absolute Estate in fee Simple and have in my
 selfe full power and Lawfull Authority to sell & Convey
 of same as above and that of s^d John Andrews his heirs
 & Assignes shall and may from time to time and at all
 times for ever hereafter by force & Vertue of these presents
 peaceably & Quietly possess & Enjoy y^e same furthermore
 y^e said Thomas Day for my selfe my heirs Exec^r adm^r
 do Covenant and Engage y^e demised promises to him y^e s^d
 John Andrews his heirs & Assignes against y^e Lawfull
 Claims or demands of any person or persons whatsoever
 for ever hereafter to warrant secure & Defend In
 Witness whereof I have herunto set my hand and

Jan^r. Andrews all y^e Said Lott or Division of Thatch
his Heirs Exec^{rs} adm^{rs} & Assignes for ever To Have
& To Hold quietly & peaceably to use Improve possess
& Enjoy without any Lett hindrance Denial or
Opposition of me my Heirs or Assignes for ever
Warranting my right & title to y^e same to be good
& Lawfull so as not to alter Change Null Defeat or
make void y^e same for ever but hereby Covenant and
oblige myself my Heirs & to keep safe & Indemnified
y^e Said Jan^r Andrews his Heirs & Assignes for ever in
y^e possession of all y^e Demised promises from any person
